- (i) Overall monitoring of Anti-Ragging activities of the Medical College
- (ii) Ensuing compliance with the provisions of the National Medical Commission (Prevention and Prohibition of Ragging I Medical Colleges and Institutions) Regulations, 2021 as well as the provisions of any law for the time being in force;
- (iii) Monitoring the activities of Anti-Ragging Squad;
- (iv) Investigate reports of ragging, if any, or approve committees formed for this purpose;
- (v) Make suggestions for improvement of measures taken by the Medical College for prohibiting and preventing ragging.

2. TENURE OF THE MEMBERSHIP :

- (i) The tenure of all the Members, shall be for three years from the date of issue of this Notification or till such time they hold the position through which they represent whichever is earlier.
- (ii) Notwithstanding the above said term of office, the Dean and the Chairperson of the Committee shall have the power to terminate any Member(s), at any time before the expiry of his/her term, without any Notice, in case if found that he/she is acting prejudicial to the interest of the students of the SVS Medical College.

3. MEETINGS:

The 'Anti Ragging Committee' shall meet at as and when need arises to discharge any urgent issues or any suggestions received from the 'Anti Ragging Squad' for consideration.
