2. TENURE OF THE MEMBERSHIP:

- (i) The tenure of all the Members, shall be for two years from the date of issue of this Notification. The Members shall not be eligible further unless everyone has completed one full term or if he/she accepts any appointment in other College / University or if he/she does not attend three consecutive meetings of the Pharmacovigilance Committee without proper leave of absence in writing to the Chairman, he / she shall cease to be a Member of the PVC.
- (ii) Notwithstanding the above said term of office, the Chairman of the PVC and Head of the Institution as the Dean of the SVS Medical College shall have the power to terminate any Member(s), at any time before the expiry of his / her term, without any Notice, in case if found that he/she is acting prejudicial to the interest of the SVS Medical College or in an act of considered to be unethical.

3. MEETINGS:

The PVC shall meet as and when need arises to discharge any urgent issues reporting regarding adverse reactions associated with drugs used or in use of any new drugs or in relating to drug abuse and drug use in pregnancy etc.

4. POWERS AND FUNCTIONS :

The powers and functions of the PVC shall be as stipulated in the 'Pharmaco Vigilance Guidelines' of the Drug Regulatory Authority and the Department of Health's Essential Drug Program.
